TERMS OF REFERENCE

Communication Consultant to develop and design the Country Program Profile and Key Program Area Factsheets

1. Background

Catholic Relief Services (CRS) is the international humanitarian agency with the head office in the United States. CRS works to save, protect, and transform lives in need in more than 100 countries, without regard to race, religion or nationality. CRS began working in Vietnam in 1992 and established an office in Hanoi in 1994. In partnership with government and communities, CRS implements programs in ten provinces/cities across Vietnam. CRS Vietnam assists local partners in the areas of inclusion of people with disabilities, Explosive Ordnance Risk Education and victim assistance, Disaster Risk Reduction and Management, and Community-based Climate Change Adaptation.

CRS is looking for communication consultant(s) to develop and design the Country Program Profile and Key Program Area Factsheets in accordance with CRS branding guidance and policy.

2. Scope and methodology

The Consultant will review the current communication materials and interview CRS Vietnam staff, specifically Country Manager, Program Managers and Operation Manager to develop and design the following documents:

- One 2-page Country Profile
- Four 2-page Key Program Area Factsheets

The country profile and Key Program Area Factsheets are CRS communication material targets primarily donors and potential partners. The country profile can be a stand-alone document or it could be shared with donors and partners in conjunction with Key Program Area factsheets. These documents will be updated once a year.

The Country Profile's outline:

- Page 1: Key Country Program Statistics provides a quick snapshot of our reach and scale.
- Page 2: introduces the key programming areas and the relevant projects under each of these areas.

Key Program Area Factsheet's outline:

- Program background, goals, objectives, program location, Program strategy/key interventions, key figures, etc;
- Highlights of selected projects.

The Consultant will select illustrating photos available in the Country Program.
