

TERMS OF REFERENCE TECHNICAL CONSULTANCY ON COMMUNITIES' COMMUNICATION CAPACITY SHARING (Re-advertisement)

1. Background

Oxfam is a global movement of people who are fighting inequality to end poverty and injustice. There are currently 21 member organizations working in 87 countries. We have a vision of a just and sustainable world. A world where people and the planet are at the center of our economy. Where women and girls live free from violence and discrimination. Where the climate crisis is contained. And where governance systems are inclusive and allow for those in power to be held to account.

Oxfam in Vietnam believes that a reduction in poverty, injustice, and inequality will occur through the interaction between active citizens, accountable states and responsible private sector and that it is fundamental to Vietnam's development. Oxfam in Vietnam aims to influence the current growth-based development model to shift to a Human Economy Development Model, putting people and the planet before profits.

Fair for All (F4A) is a global initiative funded by the Dutch Ministry of Foreign Affairs. The main purpose of the global program is to make value chains and trade in 14 countries more inclusive and sustainable. Fair for All in Vietnam is part of this global initiative.

This document describes the Terms of Reference for the technical consultancy to conduct Communication capacity sharing with community groups.

2. Scope of work

The consultant team will work with Oxfam and local partners in facilitating planning, provide trainings as well as provide follow up support after trainings, including:

- Faciliate the developmenent of interative communication capacity strenthening plan of Oxfam's partners and communities based organizations (CBOs)
- Provide training for Oxfam's partners and CBOs on interactive communication
- Supporting partners and CBOs in developing their communication products

3. Deliverables and schedules

- One communication capacity sharing plan for communities by Sept 30th, 2023.
- At least 2 training sessions and 15 coaching sessions for 4 CBOs and 1 partner by Feb 15th, 2024
- Support 1 partner and 4 CBOs in developing their communication products
- At least 4 final communication products of CBOs are supported by the consultant by June 30th, 2024
- One consultancy report on the implementation and results of the trainings and production progress, March 31st, 2024.
