TERMS OF REFERENCE

Consultant for Anticipatory Action simulation

Project: Anticipatory Action

1. BACKGROUND

Catholic Relief Services (CRS) has been operating in Vietnam since 1994. In partnership with government, social organizations and communities, CRS implements programs in 12 provinces/cities in Vietnam. The Vietnam Program has a diverse funding base in the sectors of Emergency, Disaster Risk Reduction (DRR) and Climate Change Adaptation; Disabilities; Mine Risk Education and Landmine Survivors' Assistance.

In collaboration with local partner, we are implementing the Anticipatory Action (AA) project aiming to build the resilience of vulnerable communities in Central Vietnam which will support communities to reduce and mitigate flood and typhoon disaster impacts through AA before a disaster occurs.

In order to provide opportunities for government authorities and communities look into the implementation of AA from the day the target commune receives the trigger until before the impact occurs, CRS would like to recruit a consultant, together with CRS staff and our implementing partner, to develop the AA simulation scenario and facilitate the AA simulation in the field.

2. OBJECTIVES

- To validate the AA Protocol and its assumptions.
- To test the coordination mechanisms of internal and external stakeholders with a role in the AA Protocol and Identify possible challenges in coordination among stakeholders involved.
- To test the feasibility, viability and timeliness of the anticipatory actions
- To gain insights for refining the Anticipatory Action Protocol which will allow all those involved to better understand their roles and responsibilities in the event of an activation.

3. CONSULTANT TASKS AND RESPONSIBITIES

The consultants will take active role to conduct the assignment with support from CRS Vietnam. Specifically, the consultants will be responsible for the following tasks:

- Develop the AA simulation guideline including scenario for 2 major phases Readiness phase and Anticipatory Action phase in the target area.
- Facilitating the AA simulation exercise in the target area with CRS staff and implementing partners
- Developing the AA simulation exercise report
- Finalizing the AA simulation guideline based on the insight gained from the AA simulation exercise

The task will commence in August 2024 and will be completed by fourth week of September 2024. The tentative time frame is as follows:
