## **ANNEX 1: TERMS OF REFERENCE**

# 1 BACKGROUND

# Aus4Skills Program

The Aus4Skills Program supports Vietnam to access and use high level professional and technical knowledge, skills and competencies, to contribute to the country's sustainable economic and inclusive development. The Program also aims to deepen Vietnamese and Australian people-to-people and institutional links and therefore strengthen the partnership between the two countries.

Aus4Skills seeks to achieve the following three whole-of-program outcomes:

- Inclusive alumni use new skills and knowledge to make positive contributions to targeted areas of Vietnam's development.
- Selected Vietnamese Government, private sector, civil organisations and other partners demonstrate organisational change through improved policies, practices or performance standards in targeted areas.
- Australia and Vietnam have stronger sustainable links and partnerships in selected agencies.

# Australian Alumni Grants Fund

The AAGF, implemented under the Aus4Skills Program, funds proposals from Vietnamese alumni of Australian education institutions to: (i) consolidate their professional knowledge and skills gained in Australia; (ii) contribute to organisational and institutional change in selected Vietnamese government, private sector, civil society and other partner organisations; and (iii) strengthen linkages between Australia and Vietnam.

Since 2016, six AAGF rounds valued at a total of approximately AUD 2,680,000, have been administered by Aus4Skills. Funded projects have involved a wide variety of professional, community development and capacity building activities, public awareness and advocacy activities, and organisational and institutional change activities in priority sectors. ## **Review Details**

The Consultant will conduct a desk review of relevant documents, consult with relevant stakeholders, and prepare a report of no more than four pages on findings and recommendations for the financial management of future AAGF rounds as further described below. The proposed period of the Activity will be two months, from September to October 2024.

# **3 REQUIRED INPUTS**

## 3.1 Consultant input

- excellent written and spoken English skills
- experience in compiling good practice documents on fraud control and financial management.
