TERMS OF REFERENCE

Documentation of the Vietnamese Red Cross contribution to the HFA / ASEAN ADDMER Work Plan

Background

In November 2013, the International Federation of Red Cross and Red Crescent Societies (IFRC) launched the "Building Regional Capacity and Collaboration for Community Resilience in Southeast Asia" (C3R) project, which is a 3-5-year initiative funded by the Canadian Government and the Canadian Red Cross. This project is supporting the 11 National Societies of the region with the overarching goal of reducing the impact of natural disasters on vulnerable communities in Southeast Asia.

Regionally, the Association of Southeast Asian Nations (ASEAN) Secretariat is the key driver of DRR¹ and regional approaches to environment and climate change adaptation (CCA).² The ASEAN Socio-Cultural Community is responsible for building disaster-resilient nations and safer communities within the region under the ASEAN Committee on Disaster Management (ACDM) sub-committee and comprised of national-level Disaster Management Agencies. The ASEAN Agreement on Disaster Management and Emergency Response (AADMER), adopted in 2005, and the AADMER Work Programme 2010-2015 represents ASEAN's commitment to the HFA (as reported in the 2013 ASEAN HFA review report).

The consultancy will represent the first step towards supporting SEA National Societies to utilize existing cooperation mechanisms and tools to build greater collective responsibility and trust, nationally and regionally. Through the review and mapping of the VNRC National Society's initiatives in DRR as well as the identification of existing partnerships and coordination mechanisms, it will bring evidence about the concrete contribution of the VNRC National Society to both national and regional DRR priorities.

Vietnam Red Cross (VNRC) has engaged extensively in supporting the Government of Vietnam in DRR and is well positioned within the Vietnam Disaster Management sector, illustrated by the following points:

- The legal basis of VNRC is based on the Red Cross Law of 2008. This sets out the legal ability for VNRC to engage in emergency response. The Law on Vietnam Red Cross's activities (no. 11/2008/QH12) and the Statute of Vietnam Red Cross (Amendment in 2008) specify that the Vietnam Red Cross is responsible for evaluating damages and needs, and in organizing emergency relief and recovery activities in response to natural disasters.
- The decree 64/2009/ND-CP of the Government specifies how the Vietnam Red Cross can mobilize
 national and international resources, and utilize these resources in carrying out relief activities. VNRC
 is a member of the central committee for flood and storm control at all levels from National to
 commune level This places VNRC in a very important position regarding coordination and
 implementation of humanitarian assistance
- VNRC are a member of key coordination and technical working groups including the Joint Advocacy Networking Initiative, Disaster Management Working group, Climate Change working Group and the CBDRM technical working group
- VNRC has signed a bilateral MOU with the Disaster Management Centre (DMC) to support the government in implementation of the CBDRM program to 2020 in 6000 communes.

- VNRC and the Ministry of health have signed a joint resolution N0:03/NQLT-BYT-HCTD "On Coordination in the protection, care and improvement of peoples health 2011-20" that outlines the joint areas of cooperation (Health Education, First Aid, Voluntary Blood, tissue and organ donation, humanitarian medical services, epidemic prevention, emergency health and charity meals)
- VNRC participates on the National Steering Committee on pandemic and epidemics and at the request of the Ministry of Health has been involved in responding to disease outbreaks e.g. the Hand, Foot and Mouth in 2011-2012.
- VNRC prepared a background study on the Law and Regulation for the Reduction of Risk from National
 Disasters in Vietnam, which was subsequently used as part of the Ministry of Agriculture and Rural
 Development analysis of the DRR institutional framework in Vietnam resulting in the development of
 the new Law no. 33/2013/QH13, ON NATIONAL PREPARDNESS AND RESPONSE, approved in 2013 for
 implementation in 2014.

Alignment to the IFRC's objectives and strategy

(IFRC's Strategy 2020)

In 2009, the Southeast Asia National Societies agreed to employ the risk reduction framework, *Reducing the Risks: A Framework for DRR in Southeast Asia*, as their working document for advancing DRR, nationally and regionally. This Framework builds into the IFRC Framework for Community Safety and Resilience and aligns with IFRC's Strategy 2020: Saving lives Changing Minds. The South-East Asia Regional Delegation office, based in Bangkok, Thailand, is responsible for coordinating and supporting the 11 Southeast Asian National Societies based on its Long-term Planning Framework (LTPF) 2012-2015.

Consultancy objectives

The consultancy will identify VNRC's existing cooperation mechanisms, activities and tools in the field of DRR so to document its overall contribution to the HFA (2005- 2015) and AADMER work plan 2010-2015.

Desired outcomes

- 1. The provision of technical support to VNRC in order to consolidate, document & promote its role & contribution to both national-level HFA implementation and Southeast Asia regional DRR efforts.
- 2. Finally, it is to be noted that similar documentation is being conducted in 6-7 countries throughout Southeast Asia and a regional report integrating all the national-level documents will be launched at the end of 2014 to support advocacy and partnerships enhancement with regional stakeholders.

Consultancy outputs

- 2/ Produce a technical report depicting tangible qualitative and quantitative contributions of VNRC to the ASEANAADMER programme implementation from 2010 to 2013.
- 3/ For each of the two reports, produce a one-page info graphic presenting the key messages of the report.

The format for both reports⁶ will be provided by the IFRC and will be linked to the HFA as well as the AADMER Work Programme 2010-2015⁷), including gender and environment components.

All outputs listed above should be produced in both Vietnamese and English.

Method of delivery and reasons for selecting that method

ANNEX 2 - Initial guidance note on the expected reporting format

This objective of this note is to give more clarity to potential consultants about the expected format for each of the reports to be produced. At the inception of the working period, a more detailed reporting format will be discussed with the consultant.

A/ HFA Report

The report will contain at least the following components:

- 1/ An executive summary
- 2/ A description of the methodology used to produce the report, including data collection and analysis methodology.
- 3/ A description of the concrete contribution from the National Society to the HFA based following the template used by governments to report on their commitments to the HFA, which includes progress towards:
 - The 3 strategic goals
 - The 5 priorities for action
 - The 4 cross-cutting issues / key drivers of progress
 - Way forward

Following the HFA country reporting format, each section should contain both a **description** of the activities implemented (with aggregated facts, figures, maps and charts about such contribution, e.g. number of trainings held, villages covered by community-based activities, budget spent by year, etc.) and an **analysis** of the context and constraints.

B/ AADMER Report

The report will contain at least the following components:

- 1/ An executive summary
- 2/ A description of the methodology used to produce the report, including data collection and analysis methodology.
- 3/ A description of the contribution from the National Society to each of the four strategic components of the AADMER Work Programme (see annex 1):
 - Risk Assessment, Early Warning and Monitoring
 - Prevention and Mitigation
 - Preparedness and Response
 - Recovery

Within each component, the report should contain:

- Aggregated facts and figures about the contribution (such as number of trainings held, villages covered by community-based activities, budget spent by year, etc.). This should include narrative and financial information and maps / pictures to support the description.
- Analysis of key strengths, challenges and opportunities related to this particular component
- Analysis on the level of gender and environment inclusion in this contribution

Annexes of both reports should include:

- A digital copy of all digital documents reviewed, sorted by language and thematic
- A list of key informants met

ANNEX 3 - List of documents to be reviewed and persons to be interviewed
