- Result 1 is around helping DMC with establishing the implementation of the CBDRA regulation. There will be a resource center established – IFRC has requested DMWG to send relevant documents (CBDRM, frameworks, assessments, tools). IFRC will follow up individually. Advice from DMWG was to start with VUFO and DMWG website.
- Result 2 is the review of the VCA, an evaluation of VCA process, and comparative analysis with CBDRA. Looking at pros and cons for each and looking at strengthening gender CCA, etc.
- Result 3 is a review of the Provincial Response Teams (PDRT)

CARE

- Implementing DIPECHO project to support the national CBDRM, documenting best practice, focusing on remote mountainous areas.
- Project working with Plan and Save the Children.

World Vision

- Project in Thanh Hoa province is looking at communication materials on DRR/CCA.
- DMWG were asked if you know any graphic designers please let World Vision know. They want a professional artist to make their materials look good.

Malteser

- Participated in the DMC CBDRM Training last month as part of the SCDM II Project.
- Collected information on the CBDRM & CBDRA processes and will distribute a report to DMWG members in Vietnamese and English on the SCDM II/DMC guidebooks.

CRS

- Project “Strengthening Community Resilience to Coastal Natural Hazards in Central Vietnam” in Quang Nam and Binh Dinh provinces funded by OFDA and CRS has completed. A final evaluation and Learning & Sharing Workshop among the partners and community members were conducted. The successes, challenges, sustainability and lessons learnt are being documented and will be available in Nov.

Oxfam

- Working on SCDM II project to support government rollout 1002 program for 2014. Working in 20 provinces, the 4 implementing agencies VNRC, VWU, Oxfam, DMC have 200 master trainers at provincial level from different line agencies. The 200 master trainers then roll out the CBDRM in about 50 communes. Oxfam is working in 6 provinces.
- 2014 is important year to collect feedback and lessons learnt on the two guidebooks CBDRM & CBDRA, DMC is aiming to update and finalize the guidebooks in December 2014.
