4. Evaluation:

A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 70% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

An interview with the candidate given the highest combined score may be held before contract awarding, if deemed necessary.

- Full medical examination and Statement of Fitness to work for consultants from and above 62 years of age and involve travel. (This is not a requirement for RLA contracts).
- Release letter in case the selected consultant is government official.

9. Payment

<u>3rd and final payment</u>: 50% of total contract value will be paid upon satisfactory completion of the assignment and upon approval of the final report by the UNDP Viet Nam Policy Advisory Team.

If two currencies exist, UNDP exchange rate will be applied at the day UNDP instructs the bank to effect the payment.

TERMS OF REFERENCE (TOR)

International consultant to write a Background Paper on Political Economy of Socialisation in Viet Nam

Country of assignment: Viet Nam and home base

Duration: 35 working days to be used between early September

and 15 December 2012.

1) GENERAL BACKGROUND

Until the early 1980s social services in Viet Nam were almost entirely state financed and provided by State entities and institutions. Under the state-socialist system with its universalist principles access to social services was a formal citizen right. A degree of inequality existed with state elites and those closely linked to the bureaucracy as well as urban centres enjoying greater access and quality services.

With rapidly declining state revenues in the 1980s, the fiscal foundations of universal social service provision and public service institutions eroded. The government started to reduce state subsidies and to call for the 'mobilisation of resources from society'. The 1990-2000 Socio-Economic Development Strategy (SEDS) first introduced the concept of cost-recovery. According to the 1992 Constitution the State should give priority to investments in education while promoting other sources of investment (Art. 36) and mobilise and organise all society to build and develop the health system (Art. 39). It also included provisions for policies on school and hospital fees. The 8th Party Congress in 1996 reiterated the central role of the state and mobilising people, enterprises, social organisations, foreign individuals and organisations to work together to resolve social problems. Subsequent policy documents and Party resolutions expanded the concept and provided guidance on its implementation. The 2011-2020 SEDS emphasised the importance of socialisation for education, health, culture, sport and environmental protection. SEDP 2011-2015 further added poverty reduction, population and reproductive health. Other areas such as tourism, business registration, issuance of land certificates and water have also started to be subject to the application of socialisation policy.

This recent expansion in both content and scope is neither based on evidence-based assessments of the impact of the policy so far nor is it fully backed-up by the constitution, other important government documents and strategies. It is also occurring in a different context. While initial socialisation policies were introduced in a context of fiscal scarcity, economic growth has led to an increase in government revenues. Although Government expenditures for health and expenditure have risen in absolute terms, there has been an increasing shift towards capital expenditures. The current expansion of socialisation therefore seems more a reflection of a conscious choice towards a (capital) investment led growth model and marks a significant departure from a more balanced socio-economic development.

Over time socialisation has become an umbrella term used for 'everything from introducing fees for public services to promoting joint ventures between public and private service providers to promoting foreign investment.' In practice socialisation has been implemented as 'privatisation' and 'commercialisation' and implied shifting responsibility for the provision and payment of services from the state to society, primarily to households. Access to education and health services, especially beyond the basic level, are increasingly contingent on households' ability to mount out-of-pocket payments representing a significant burden on the poor and near-poor.

Another feature of the socialisation process in Viet Nam has been the blurring of lines between the public and private. One manifestation of this has been the proliferation of private income generation activities often within public institutions and related to the functions of public employees who derive significant proportions of their income from these activities. Resolving these conflicts of interest will be key for improving the accountability and effectiveness of service delivery and for effective regulation.

Socialisation has facilitated the privatisation and commercialisation of social services. While commercialisation can, through encouraging competition, improve access to and quality of services, in practice it has often led to an overprovision of services and to higher costs. This contributes to increasing inefficiency and entrenching out-of-pocket payments, therefore to inequality in terms of access to affordable services. The limited regulatory and redistributive role of the state facilitates this process.

As Viet Nam is discussing new growth models it is timely to revisit the socialisation policy and to strengthen the regulatory and redistributive functions of the state.

2) OBJECTIVES OF THE ASSIGNMENT

An International Consultant will be hired, to produce a background paper on the political economy of socialisation. This paper will provide the basis for further work on this issue and provide suggestions for entry points (in terms of research and programs) and advocacy.

3) SCOPE OF WORK

The background paper should sketch out the main issues only, review existing literature and identify gaps where further research may be required. A list of main research questions can be found below.

The paper will analyse the issue of socialisation from a political economy perspective. Each section should compare the experience of Vietnam with the one of China and/ or other relevant country experiences.

4) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

The total allocation for this assignment is 35 working days to be used between early September and 15 December 2012.

During this period the consultant shall visit Hanoi two times. The first visit should be for 5 working days for meetings with stakeholders at the beginning of the assignment. The second visit for 3 working days to present the report findings and to discuss follow-up options with stakeholders. The exact timing of the missions will be determined in the inception phase.

5) FINAL PRODUCTS

The background paper should address the following issues. This list and the overall approach will be reviewed in discussions with UNDP and other stakeholders during the inception phase.

1. Understanding the evolution of socialisation

Some questions which should be addressed are:

- What has been the underlying rationale of the expansion of socialisation? and how has this evolved over time? How important are fiscal considerations? Administrative capacities, particularly the capacity of the government to use taxation as a mechanism of distribution? vested interests that have become entrenched over time?
- How have the underlying incentives changed? (see also question below on governance/ rent seeking and informal payments)
- · Who is driving this expansion? Who is resisting?
- How is socialisation viewed by different stakeholders? what is the official line? are there differing views within the Party? what about the public (reactions in the media, on blogs, etc.)? National Assembly?
- To what extent is the discussion part of the larger debate in Vietnam about the role of the state and the 'new growth' model? the debates about universal access?

This part would document references to socialisation in main legal and planning documents.

It should include a mapping of 'socialised sectors' with a brief analysis of the expansion of scope in terms of areas/sectors as well as actors including:

- Education
- Health
- Water
- o Leisure
- Social protection, care for the elderly, etc.

This also includes an analysis of the different modalities of socialisation.

2. Governance Aspects

Blurring of public - private spheres/ rent seeking

Another feature of the socialisation process in Vietnam has been the blurring of lines between the public and private. One manifestation of this has been the proliferation of income generation activities often within public institutions. Some public employees derive significant proportions of their income from these activities.

Some questions which should be addressed are:

• The relationship between socialisation and informal payments. How important are informal payments? What additional research should we look at? (small scale surveys, etc.)

Socialisation and decentralization

The financing and management of public services including the provision and payment for education and health services has largely been decentralised. The stated aims of these policies are to allow service delivery units to mobilise economic resources, to expand the range and improve the quality of services and increase responsiveness to public needs. The way the policy has been applied at the local level is very different.

- What has been the impact of decentralization on public service delivery (in terms of coverage, access and quality)?
- While there is quite a lot of information on education and health, what about water and other areas? Where are the gaps in knowledge?

3. Impact on Vulnerable Groups and Inequality

Access to education and health services, especially beyond the basic level, are increasingly contingent on households' ability to mount out-of-pocket payments. The poor spend bigger shares of their incomes on health and education.

- What quantitative evidence is available on the impact of socialisation? This should provide a quick overview of available studies on the impact of socialisation on vulnerable groups (poor, near poor, etc.).
 Where are the research gaps?
- How is socialisation contributing to inequality? This should look at various dimensions of inequality.

Future Options

- Additional research?
- What are potential policy options in light of recent discussions about the social protection system? This should provide lessons learnt from other countries.

6) PROVISION OF MONITORING AND PROGRESS CONTROLS

The overall dialogue process will be managed by the Policy Advisory Team (PAT) of UNDP.

The PAT Policy Advisor on Economics will:

- a) convene and facilitate various meetings with national and UN/international stakeholders;
- b) provide inputs into the research methodology and review drafts of the report.

Overall facilitation of workshops will be by UNDP-Viet Nam (PAT) and the national research organisations. They will make several resource people available as peer reviewers of draft results and participants in various dialogues.

7) EXPERTISE AND QUALIFICATIONS

The consultant will have:

- a. At least 10 years experience in social policy research;
- b. In-depth knowledge of social policy and in particular socialisation policies in Viet Nam;
- c. Familiarity with social policy issues in China and/ or other relevant countries;
