- Advanced degree in medicine, public health, or a related discipline.
- Over 10 years of experience working in Vietnam on public health, and /or HIV programming and prior work experience in a non-governmental organization (NGO) or government agency.
- Comprehensive understanding of MOH and provincial health services and issues relevant to the eventual successful integration of current donor-supported programs into sustainable national and provincial responses.
- Strong communication, leadership and interpersonal skills. Demonstrated ability to build and maintain relationships with a wide array of professionals working in a complex network of organizations and agencies in Vietnam including non-governmental, donor and national and local health and related institutions.
- Ability to manage projects, set realistic priorities, and plan for the successful implementation of programs.
