Maximum 1000 points will be given to the lowest financial offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. $Sf = 1000 \times Fm / F$, in which Sf is the financial score, Fm is the lowest price and F the price of the proposal under consideration.

The weight of technical points is 70% and financial points is 30% of the obtainable points

Individual consultants will be evaluated based on Cumulative analysis, the award of the contract will be made to the individual consultant whose offer has been evaluated and determined as:

1. Background

Since 2009, the United Nations Development Programme (UNDP), in collaboration with the Viet Nam Fatherland Front (VFF) and the Centre for Community Support and Development Studies (CECODES), has developed the Vietnam Provincial Governance and Public Administration Performance Index (PAPI) for Viet Nam. PAPI is aimed to gauge the perception and experiences of non-state actors, in particular of citizens regarding local governance and public administration performance at the provincial level.

PAPI aims at hearing the voice of citizens from different demographic backgrounds that remains weak in policy making, policy implementation and implementation monitoring. PAPI also means an effective and peculiar tool for citizens to engage in overseeing the performance of the state apparatus and public administration system at the provincial level. Ultimately, the provinces and cities will be provided with a powerful tool to advance the process of empowering the society, to enhance local governance and to support national efforts in keeping the public administration system and local governments accountable to citizens and the society at large.

The initiative was piloted in three provinces in 2009 and then expanded for larger pilot in 30 selected provinces in 2010. With the success of the pilots, PAPI has been conducted on an annual basis since 2011 in Viet Nam, with nearly 62,000 citizens from different demographic and professional backgrounds interviewed individually to date. PAPI involves different research stages that require specific quality control mechanisms in place. Some of the mechanisms are independent sampling, field survey spot-check with independent monitoring and re-interviewing for double-check of collected data, and external re-data entry for double-checking of first data entry by PAPI implementers. All these processes need quality control by an experienced international expert that is capable of providing technical advice, support and analysis for each of the quality control mechanisms being done by national partners.

This TOR sets forth the requirements for an International Expert on Research Quality Control for the PAPI initiative for the period from 1 December 2014 to 31 July 2015.

2. Objectives

- To provide international expertise in and advice on research quality control for the PAPI initiative, in particular,
 - To analyse data collected through different quality check processes by matching different datasets to point out synergy and/or differences to inform UNDP
 - o To support with sampling of PAPI population using the PAPI sampling framework
 - To support with analysis of national trends and time series data and elaboration of high quality graphs from PAPI data

3. Expected Outputs

The International Expert, according to the following terms of reference and under the coordination of UNDP Vietnam, shall deliver the service by three stages with 30 working days and 01 two-week mission in Hanoi in December 2014 (required, preferably before 20 December 2014) and 01 five-day mission in May/June 2015 (when deemed necessary), as described below:
