There are many development programmes targeting the ethnic minorities (EM) and focusing on the poorest communes and districts in Vietnam. Despite all efforts, the poverty rate of the group still remains high. The EM groups account for 14% of the whole population but hold 47% of the poor and 68% of the extreme poor in 2010 - and the gap between minority populations and the Kinh majority continues to widen. One of the primary reasons seems to be the lack of local participation in the development, from the identification of needs to monitoring of the development process.

The mainstreaming of local participation in socio-economic development plan (SEDP) plays a key role in bringing about appropriate income generation opportunities to the local people and actualizing community potential. It is vital that the ethnic minorities can act as active players in their own development process.

In order to share some good models in strengthening local participation in development programmes, the EMWG would like to invite you to the sharing meeting on *integration of local participation in SEDP – good practices in Ha Giang, Hoa Binh and Cao Bang provinces*.
