## Rights on community forest and the importance of forest land to ethnic minorities in Vietnam

Vietnam has 3/4 mountainous area and 53 ethnic minority groups with more than 14 million people, accounting for 14% of the total population of the country. The ethnic minorities (EMs) mainly settle in mountainous and remote provinces of Northwest, Northeast, Central and Central Highlands. Their daily life, including livelihoods, water resources, practices of culture and spiritual belief, and material resources to build houses, etc ...depends on land and forest resources. It is the ethnic minority communities who nurture forests. They play a key role in protecting them, water resources and national security and defense.

To better understand the role of forests towards ethnic minority communities and the mutual relationship between forests and the community, The Centre of Culture Identity and Resources Use Management (CIRUM), and some members of the Ethnic Minorities Working Group (EMWG) would like to invite you to the learning forum on "Rights on community forest and the importance of forest land to ethnic minorities in Vietnam".
