











"Renewable energy development in Vietnam and the role of NGOs"

INTRODUCTION

In December 2011 the Government of Vietnam approved the National Climate Change Strategy (NCCS), which clearly states that the development of renewable energy (RE) as one of the key tasks to reduce greenhouse gas emissions (GHG). With Vietnam's rapidly growing energy demand, renewable energy development is receiving increasing attention from the National Assembly, the Government, and development partners, however to date there has been little stock-taking and discussion of the role and contribution of NGOs. The CCWG Mitigation Sub-group is organising this workshop combined with a field visit to put focus on the contributions and potential role of NGOs in renewable energy development in Vietnam.

- 1) Sharing and updating information on the current status of renewable energy development and existing and new energy policies in Vietnam;
- 2) Discussing opportunities, challenges, and lessons learned of NGOs in renewable energy development in Vietnam.
