It is my pleasure to invite you or your representative to participate at the National Closing Workshop of the development of a Framework for Implementing and Mainstreaming Ecosystem based Adaptation (EbA) in Viet Nam on November 29th, 2013 in Kim Do Royal City Hotel, 133 Nguyen Hue Ave. District 1, Ho Chi Minh City, Viet Nam.

Climate change is a defining development challenge, which already poses significant threats to livelihoods and the economy in Vietnam. This call for responses that will help build resilience and decrease vulnerability of ecosystems and the communities that rely upon these for their subsistence. Ecosystem based adaptation (EbA) provides nature based solutions to reduce vulnerability of people while simultaneously generating a range of significant social, economic and environmental co-benefits.

Responding to Vietnam's need for a detailed guidance to assess and implement EbA, the World Wildlife Fund and The Institute of Strategy and Policy on Natural Resources and Environment (ISPONRE) jointly developed a framework for EbA in Viet Nam with support from the World Bank in the context of a regional effort to develop EbA in the Mekong subregion. The framework and testing was done under the guidance of MONRE and other key line ministries in Viet Nam between July 2012 and October 2013.

The meeting is hosted by ISPONRE/MONRE together with WWF. It aims to share the findings and lessons learned from the field-testing and present the final draft framework, which has benefited from a series of consultations in the past 18 months. In this context, the objective of this event is also to take this opportunity to discuss mainstreaming of EbA and potential future collaborations towards the scaling-up of EbA in Viet Nam.
