The United Nations Development Programme (UNDP) has been in collaboration with Ministry of Industry and Trace (MOIT) and businesses in chemical fertilizer sector to develop a project proposal "Enabling Greenhouse Gas Emission Mitigation Initiatives in the Chemical Fertilizer Industry in Viet Nam" to mobilize funding from the Green Climate Fund (GCF).
