



## Invitation Letter

### Regional workshop about the engagement of civil society organizations in Paris Agreement Implementation Plan at provincial level

In 2016, The Nationally Determined Contribution (NDC) of Vietnam was officially approved by the Government. According to the plan, 63 provinces must develop and submit the provincial implementation plan of Paris Agreement (PA) to the Ministry of Natural Resources and Environment (MONRE) by the end of 2019 in order to consolidate to the national implementation plan of PA. As to date, the majority of provinces have developed and submitted their implementation plans. Now they face the challenge of effectively implementing them. This challenge presents an advocacy opportunity for Climate Change Working Group (CCWG) to assist provinces to perform their pledges by integrating and replicating NGOs' successful models into the implementation plan of PA at provincial level.

Therefore, with the support from Oxfam – core member of CCWG, the network is going to organize two regional workshops in Da Nang and An Giang province in order to:

- ✓ To create the platform for CCWG members with some provinces to dialogue and explore the cooperation opportunities,
- ✓ To introduce the network's successful rice and energy sector models to decision makers and stakeholders for consideration of replication;
- ✓ To share the possibility of raising NDC's ambitions and effective implementation of PA by integrating NGOs' initiatives into provinces' plan of implementing Paris Agreement;
- ✓ To reach an agreement on how CSOs can contribute to the Paris Agreement Implementation plans.

**Tentative date:** 21<sup>st</sup> – 27<sup>th</sup> December 2018

**Location:** one workshop in Da Nang province – one workshop in An Giang province

**Delegates:** representative from many provinces in Mekong delta and central of Vietnam, development partners, CCWG members, institutes and researchers
