A two-stage procedure is utilized in evaluating the submissions, with evaluation of the technical components being completed prior to any price proposals being opened and compared. The price proposal will be opened only for submissions that passed the minimum technical score of 80% of the obtainable score of 1000 points in the evaluation of the technical component.

The technical component is evaluated on the basis of its responsiveness to the Term of Reference (TOR).

Maximum 1000 points will be given to the lowest offer and the other financial proposals will receive the points inversely proportional to their financial offers. i.e. Sf = 1000 x Fm / F, in which Sf is the financial score, Fm is the lowest price and F the price of the submission under consideration.

The weight of technical points is 70% and financial points is 30%.

Submission obtaining the highest weighted points (technical points + financial points) will be selected.

Interview with the candidates may be held if deemed necessary.

8. Contract

"Lump-sum" Individual Contract will be applied for freelance consultant (Annex II)
"Lump-sum" RLA will be applied for consultant assigned by firm/institution/organization (Annex III)

- International consultant whose work involves travel is required to complete the course on Basic Security in the Field and submit certificate to UNDP before contract issuance.

Note: The Basic Security in the Field Certificate can be obtained from website: https://training.dss.un.org/consultants. The training course takes around 3-4 hours to complete. The certificate is valid for 3 years.

- Full medical examination and Statement of Fitness to work for consultants from and above 62 years of age and involve travel. (This is not a requirement for RLA contracts).
- Release letter in case the selected consultant is government official.

9. Payment

UNDP shall effect payments to the consultant (by bank transfer to the consultant's bank account provided in the vendor form (Annex V) upon acceptance by UNDP of the deliverables specified the TOR.

<u>1st payment</u>: 10% of total contract value will be paid upon receipt and acceptance by UNDP/BCA on the work plan;

<u>2nd payment</u>: 40% of total contract value will be paid upon submission of draft report on overview of international experience, approach/methodology, and suggestions for mainstreaming biodiversity into sectors (focusing land use planning).

<u>3rd payment</u>: 20% of total contract value will be paid upon submission with satisfactory acceptance by UNDP/BCA of the field visits report.

4th and final payment: 30% of total contract value will be paid upon satisfactory completion of all tasks. The final draft reports will be provided to BCA (MONRE) and UNDP CO for review 10 days prior to the end of the contract period.

If two currencies exist, UNDP exchange rate will be applied at the day UNDP instructs the bank to effect the payment.

TERMS OF REFERENCE (TOR)

Title: International Consultant to assist with mainstreaming biodiversity

conservation priorities into land use planning

Duty Station: Home base and at the two project pilot provinces.

Duration: 6 working weeks, during period from October 2013 to October 2014

Project ID and title: UNDP/MONRE – "Developing National Biodiversity Strategy and Action Plan

1) BACKGROUND

The Government of Vietnam has made a strong commitment to environmental conservation. Since 2006, Vietnam's Government has started to allocate 1% of the national budget for environmental protection. The national budget allocated to biodiversity conservation appears in two forms: central budget and provincial budget. The average spending for biodiversity conservation constitutes about 0.4% of the total national budget. However, it has been noted that much of the "investment for biodiversity is limited and untargeted; usually focusing on infrastructure construction rather than for scientific research, management and protection activities" 1. It further notes that "investment in biodiversity conservation is also insufficient, when little funding is allocated to management, strategic development and legislative formulation, capacity building, and public awareness raising as well as baseline biodiversity investigation. It is estimated that nearly 90% of the biodiversity fund were spent for infrastructure construction, and only 10% was directly cost for biodiversity conservation and management. New and complex issues in biodiversity protection such as genetic access and benefit-sharing, ecosystem-based approach adoption, and terrestrial and marine biodiversity conservation have not received sufficient attention."

Vietnam's first national biodiversity strategy and action plan (NBSAP) was developed in 1995, and updated in 2007, but this was only done for the period up to 2010. In 2008, the Law on Biodiversity was enacted which specifies the roles of MONRE and the provincial authorities in biodiversity conservation. The Law highlights the importance of biodiversity conservation planning both at national and sub-national level, conservation and sustainable development of natural ecosystems, species and genetic resources, and requires having mechanisms and resources for biodiversity conservation and sustainable development. The GEF/UNDP funded project "Developing National Biodiversity Strategy and Action Plan and Mainstreaming Biodiversity Conservation into Provincial Planning" is designed to strengthen capacity both at national and provincial levels for implementation and monitoring of the NBSAP, and pilot mainstreaming biodiversity priorities into land-use planning in two provinces; the project will, therefore, provide many lesson for future biodiversity conservation planning in Vietnam.

The new NBSAP has been prepared and submitted to the government in the second quarter of 2013. In order to support the Government implement the NBSAP at national and provincial level, the project is seeking for an international consultant to assist with BCA to (i) provide an overview of international experience on mainstreaming biodiversity into sectors (focusing land use planning) and propose suggestion for mainstreaming biodiversity into land use planning in the case of Vietnam; (ii) conduct assessment of mainstreaming biodiversity conservation into land use planning and lesions learnt.

2) OBJECTIVE OF THE ASSIGNMENT

The objective of the assignment is to provide international expertise to Biodiversity Conservation Agency (BCA), which is the implementing agency under Vietnam Environment Administration, on mainstreaming biodiversity into land use planning at provincial level.

3) SCOPE OF WORK

The international consultant is to support BCA and its drafting team with the following tasks in two periods:

Year 2013 (3 weeks consultancy in October – November 2013):

- Prepare a draft Report on overview of international experience in and methodology for mainstreaming biodiversity into sectors (focusing land use planning),
- Propose suggestion for mainstreaming biodiversity into land use planning at provincial level (updated land use planning procedures and revised land use maps...) based upon report on assessment of current land use situation prepared by the national consultants.
- Incorporate feedbacks/comments, review and submit final report to BCA for publication.

Year 2014 (3 weeks consultancy in August – October 2014):

- Work as the team leader, cooperate with other national consultants to prepare interview questions, field surveys, visits at sites of demonstration (if necessary) to assess mainstreaming biodiversity conservation into land use planning;
- Develop the "Report on Assessment of Mainstreaming Biodiversity Conservation into Land use Planning and Lesion learnt" from field visits to project demonstration sites;
- Review and finalize report before submission to BCA.

4) DURATION OF ASSIGNMENT, DUTY STATION AND EXPECTED PLACES OF TRAVEL

The time allocated for this assignment is total six weeks, cover two periods of work. Task to be conducted home-based and in the two selected project pilot provinces: Son La and Quang Tri (to be confirmed in October 2013).

The first period comprises of three weeks consultancy, starting from October to November 2013. During this period, the consultant is expected to travel to and work in total of 10 days at the two project pilot provinces.

The second period comprises of three weeks consultancy starting from August to October 2014. During this 2nd period of work, the consultant is expected to travel and work in total 10 days at the two project pilot provinces.

5) FINAL PRODUCTS

Final product to be submitted in stages:

- Report on overview of international experience and approach/methodology for mainstreaming biodiversity into sectors (focusing land use planning) and propose suggestion for mainstreaming biodiversity into land use planning at provincial level in Vietnam, due date by 30 October 2013 (3 working weeks);
- "Report on Assessment of Mainstreaming Biodiversity Conservation into Land use Planning and Lesson learnt", due date by 30 October 2014 (3 weeks)

6) PROVISION OF MONITORING AND PROGRESS CONTROL

The international consultants will be supervised by Project Director/Deputy Project Director and Project Manager, and the UNDP Programme Analyst at Sustainable Development team. A team of national consultants and BCA working group will cooperate with the international consultants in the process of the reports and guideline development.

7) DEGREE OF EXPERTISE AND QUALIFICATIONS

- Post graduate degree in biodiversity, biology, zoology, environment management or related fields:
- At least ten (10) years of experience in the biodiversity conservation or policy planning,
- Familiar with land use planning procedures

- Excellent written English required. Good computer skills (writing sample must be provided for assessment)

8) ADMIN SUPPORT AND REFERENCE DOCUMENTS

BCA and the project team will assist the consultant in contacting partners when carrying out interviews and meetings; organize the consultation workshops with stakeholders; and provide administrative support to the selected consultant.

9) REVIEW TIME REQUIRED AND PAYMENT TERM

- The first installment of 10% of the total contract will be paid after agreement with UNDP/BCA on the work plan and tentative visiting programme.
- The second installment of 40% of the contract amount will be paid upon submission of draft report on overview of international experience, approach/methodology, and suggestions for mainstreaming biodiversity into sectors (focusing land use planning).
- The third installment of 20% of the contract amount will be paid upon submission with satisfactory acceptance by UNDP/BCA of the field visits report.
- The remaining 30% will be paid on satisfactory completion of all tasks. The final draft reports will be provided to BCA (MONRE) and UNDP CO for review 10 days prior to the end of the contract period.
