

Invitation for Expression of Interest

ChildFund Australia invites Expressions of Interest (EOI) from consultants to critically examine the methodologies, scope and tools used in its Development Effectiveness Framework (DEF).

In particular, the evaluation will focus on examining the methodology, scope and tools applied to facilitate Outcome Indicator Surveys, and to conduct Community Engagement and Attribution of Impact processes in country programs in Cambodia, Laos, Papua New Guinea and Vietnam.

ChildFund Australia is seeking a consultant with experience in quantitative and qualitative evaluation at community level. Experience in conceptualising, designing and implementing surveys and using a range of sampling methodologies, especially knowledge of the use of Lot Quality Assurance Sampling (LQAS), is essential. The successful consultant should have appropriate knowledge and experience of developmental projects in rural contexts, demonstrable experience and track record of quantitative and qualitative evaluation of multi-sector holistic development programs. Knowledge and experience of participatory approaches and appreciative enquiry methods are desirable.

The consultant should be available to work between March to May 2015, including availability to travel to Mekong region between March and April 2015. The work should be completed preferably by 8 May 2015.

Only one consultant will be engaged for this assignment. Upon conclusion and completion of the review, the consultant's final report will be presented at ChildFund Australia Program Summit in May 2015. Subsequently, appropriate actions to address the findings and recommendations will also be consulted and formulated during the Program Summit.

The EOI should include consultant resume, competence, cost, proposal based on TOR, man-days required to complete the work and availability.

Terms of Reference for Consultancy

To evaluate the methodologies, scope and tools used by ChildFund Australia in its Development Effectiveness Framework (DEF).

1. Introduction

ChildFund Australia is an independent and non-religious international development organisation that works to reduce poverty for children in the developing world.

ChildFund Australia implements programs with a range of local partners in Cambodia, Laos, Myanmar, Papua New Guinea and Vietnam, and manages projects delivered by partner organisations throughout Asia, Africa and the Americas. Our work is funded through child and community sponsorship, as well as public donations and government grants.

ChildFund Australia is a member of the ChildFund Alliance – a global network of 12 organisations, which assists more than 15 million children and families in 58 countries. ChildFund Australia is a registered charity and is fully accredited by the Australian Department of Foreign Affairs and Trade (DFAT).

2. Background

ChildFund Australia began building a Development Effectiveness Framework (DEF) in 2010. One of the components of the Framework was a comprehensive set of Outcome Indicators, which ChildFund's Development Effectiveness and Learning (DEL) Managers in each of its country programs measure via surveys every three years. ChildFund chose Lot Quality Assurance Sampling (LQAS) for the sampling method; field teams use questionnaires in interviews with random samples of women, children and youth and selected local government officials to collect data on the Outcome Indicators. Findings from the surveys are reported back to communities at one-day Community Engagement meetings at village, commune or district level. Participants at these meetings include representatives of affinity groups surveyed (mothers, youth and children) as well as village and commune leaders and local government officials. Community members are asked to assess the validity of findings and to use the data presented to make recommendations for direction or priorities in future development programs.

Surveys are repeated every three years. Each time the survey is completed, meetings are held with representatives from affinity groups together with leaders and officials at district level to discuss change across the program area as a whole. Each group shares their perceptions about change, the influence of various development actors and/or other factors in bringing about the change, and strives to reach an overall consensus about the relative contribution of different development actors to the observed change. This results in a "Statement of Impact" describing ChildFund's impact. Finally, based on these analyses, discussions take place regarding indicative priorities for future activities.

Objectives and Scope of Evaluation

The evaluation will focus on the tools, scope and methodologies used for the ChildFund Australia Outcome Indicator Survey. It aims to:

- 1. Assess the extent to which methodologies, scope and tools fit the purpose of ChildFund Australia;
- 2. Assess strengths and weaknesses of documents produced from the surveys, community engagements and attribution and impact workshops;

3. Provide concrete recommendations to adapt and improve existing practices, or suggest alternatives.

Analysis will focus on:

- Use of LQAS for survey sampling and data collection;
- Use of Epi-info, Access, Excel and SPSS for inputting and analysing data;
- Questionnaires and Instructions used for Outcome Indicator Survey;
- Methodologies and procedure for validation of findings; and
- Methodologies and procedure for the attribution and impact workshops.

The report should also present findings, areas for improvement and recommendations including possible alternative sampling methodologies and approaches that would still allow comparison with previous figures obtained using LQAS.

The evaluation is composed of 4 major parts:

A. Desk review and questionnaire/tools development (to interview key representatives). The desk review will look into the following documents:

- The relevant chapter of the ChildFund Australia Program Handbook;
- Current practices of applying LQAS at ChildFund;
- Questionnaires and Instructions for Outcome Indicator Survey;
- Outcome Indicator Survey reports from 4 Country Offices;
- Attribution and impact workshop report from Cambodia²;
- Community engagement reports from 4 Country Offices;
- Guidelines for survey, community engagement, and attribution and impact workshop;
- Participants' Resource-book for Attribution workshop in Cambodia; and
- Other related documents.

C. Field Work includes:

- Interviews with ChildFund staff in-country, and participants from partners and local communities (Cambodia and Vietnam);
- Observation of Attribution and Impact Workshop (Cambodia only);
- Examine use of LQAS for sampling;
- Examine data input processes; and
- In-depth discussion of issues emerging from desk review.

D. Reporting. The consultant will:

- Submit the draft report to ChildFund Australia through the Program Development Manager;
- Present the draft report to ChildFund Australia International Program Team;
- Present the draft report to DEL Managers via telecon; and
- Submit the final report.

The report should refer to the evaluation TOR and include the following elements:

- Executive summary of the main findings;
- Background information about the evaluation process, including objectives and methodologies;
- Findings and conclusions;
- Recommendations; and
- Appendices.
