S/he will participate in the study development and start-up process including reviewing protocols, designing and/or reviewing Case Report Forms (CRF), preparing Informed Consent Forms (ICF's), developing study documents, organizing and presenting at investigator meetings, working with management on a monitoring strategy, and/or developing project-specific CRA training.

Major duties and responsibilities:

- Assists in the preparation of routine protocols, informed consents, SOPs, and other appropriate documentation
- Monitors clinical trials to ensure subject safety and compliance with the study protocol, FDA regulations and ICH/GCP Guidelines
- Coordinates necessary activities required to set-up, monitor, and close-out clinical trials sites
- Conduct site assessment, initiation, routine, and close-out monitoring visits, may require supervision.

- Develops training materials and conducts training for study implementation based on company policies and SOPs.
