TERMS OF REFERENCE (Consultancy for ChildFund Australia)



TOR FOR CONSULTANCY ON NEW DISTRICT AND COMMUNE SELECTION

1. Background

ChildFund Vietnam is the representative office of ChildFund Australia, which is part of the ChildFund Alliance – a global network of 12 organizations which assists more than 16 million children in 58 countries. With a focus on child-centered development programs that are undertaken in partnership with more than 1,400 local communities, the Alliance puts more than \$503 million (USD) to work each year to help deprived, excluded and vulnerable children.

ChildFund began working in Vietnam in 1995 and operates child focused Integrated Community Development programs which are Child Rights and Child Protection, Access to Basic Quality Education and Building Strong and Resilient Communities, including but not limited to the areas of education, water and sanitation, sustainable livelihoods, food security, child rights and child protection, and maternal and child health and HIV prevention.

ChildFund Vietnam is supporting about 40,000 children in 8 districts in Northern mountainous provinces including: Na Ri and Bach Thong districts (Bac Kan province); Ky Son, Cao Phong, Kim Boi and Tan Lac districts (Hoa Binh province), Quang Uyen and Tra Linh districts (Cao Bang province) with currently 40 enrolled communes.

In the strategic plan 2015-2020, ChildFund Vietnam plans to expand to more locations in Vietnam for its support. Considering all factors, ChildFund decides to expand its CDP to one more district in Bac Kan. ChildFund Vietnam will work with provincial authorities to identify two potential districts for comparative in-depth study in order to select one district with six or seven communes.

2. Objectives

The aim of the assignment is to critically assess and recommend one district and about six to seven communes of the selected district that are

- Best fit for ChildFund to provide the support utilising a child sponsorship model.
- Best fit to ChildFund partnership engagement policy and ChildFund in Vietnam's programs, approaches.

3. Specific tasks

3.1. Study relevant documents provided by ChildFund:

- Partner's engagement policy
- Program description
- Program approach
- Childfund vision, mission and values
- Criteria for district and commune selection¹
- ChildFund Strategy 2015-2020

- Policies and guidelines on Disability, Gender and Child Protection, fraud and antiterrorism policies, DFAT policies on partners etc.,
- 3.2. Develop detail assessment outline, method, tools, as well as plan and submits to ChildFund for final approval.
- 3.3. District and Commune study Conduct assessment in compliance with approved outline.
- 3.4. Consolidate obtained information and report writing

All gathered information will be consolidated, analyzed in an appropriate manner.

The report in English following format suggested in appendix 1 should be submitted to and approved by ChildFund within the agreed time frame.

4. Methodology

4.1. Desk study

Desk study is applied for task 3.1, 3.2 and 3.4 only and arrangements as well as costs for the venue and equipment for this work are the responsibility of the consultants.

4.2. Field study

This will be applied for task 3.3. The assessment must be conducted in two separated steps:

- District assessment after completing assessment the consultants need to analyze gathered information then discuss with ChildFund in Vietnam for making decision regarding district selection. Only after that second step will be proceeded;
- Commune assessment in-depth assessing communes in the selected district to identify appropriate communes for ChildFund Vietnam to work with.

5. Time

Approximately 7 - 8 weeks, including preparation, field work, analysis and production of final report is estimated for completing this assignment. Final timeframe and detail time

Results on district and commune assessing will be combined in one report. The report should be concise and limited to significant issues. The main text should focus on the findings, conclusions and recommendations, supported by relevant summaries of data collected and citations for any references used in interpreting such data. The main text of the report should not exceed 40 pages. Detailed or un-interpreted data or other supporting materials should not be included in the main text, but may be included in an annex where appropriate.

- 3. Major findings
 - 3.1 Geographical concentration of population/demographics (including stability and in/out-migration)
 - 3.1.1 Geography:

Brief description of physical location (land form, forest, water resources, climate) and land use structure (mention rivers/coast/hills) and provide comparative analysis on accessibility in term of topography: complexity, distance from the following: nearest City/town; the most isolated hamlets to commune centre & other services (including travelling condition if any; Provincial hospital district health centre commune health station (furthest hamlet); schools (pre-school; elementary and high school)(furthest hamlet); governments' administration offices and services market;

3.1.2 Demography

Provide brief description on demography (population distribution and density by districts and communes).
