#### SCOPE OF WORK Microfinance and Start-up consultancy agency

### Project: "Scaling up Improved Household Food Security and Nutrition through Enhanced Homestead Food Production in Vietnam"

### **Introduction:**

HKI-Vietnam is a US non-governmental organization established in Vietnam in 2004. Its mission is to save the sight and lives of the most vulnerable and disadvantaged by combating the causes and consequences of blindness and malnutrition. We do this by establishing programs grounded in evidence-based research in eye health and nutrition.

To address the nutrition and food security challenges in targeted project area, HKI-Vietnam has been implementing the project: "*Scaling up Improved Household Food Security and Nutrition through Enhanced Homestead Food Production in Vietnam*" in Lai Chau and Hoa Binh provinces from 2017 to 2021. The EHFP model's ultimate goal is to improve the nutrition and micronutrient status of mothers and children under two years of age in Lai Chau and Hoa Binh provinces. The project also contributes to poverty reduction through microfinance and start-up model for village model farms (VMFs) and some beneficiary households. HKI-Vietnam therefore needs one legally permitted and qualified consultancy agency to provide services in developing the model of microfinance integrated with start-up that will be implemented in Hoa Binh and Lai Chau in year 2 of the project.

### 1. Services.

The consultancy agency will be employed to accomplish the following tasks:

- Work with Tam Duong and Lac Son Women union to set up the microfinance mechanism for EHFP project households.
- In partnership with the local partners and HKI staff to develop the guidelines for selection of best models for business start-up.
- Provide technical training/orientation for households to develop their business models.
- Report to HKI on the progress of the models including monitoring the loan management with recommendations to reduce the risks as well to improve the mechanism.
- Link the market opportunities for project families to sell their products.
