

TERMS OF REFERENCE

BSO internal resouces and processes consultation

BACKGROUNDS

HELVETAS is a co-implementing partner with SwissContact to implement the Swiss Import and Export Program. Out of the 11 countries globally, the component in Vietnam will enhance the performance of selected BSOs in Vietnam in order to enable them to provide export promotion services in two main sectors of Technical Wood (TW) and Outdoor Furniture and Value Added Textiles (VAT) in an effective, efficient and sustainable way. With this purpose, SIPPO in Viet Nam is facilitating BSOs to optimize trade opportunities so as to get them more intergrated in a global network of buyers, sellers, sector experts and other BSOs. Some of the planned interventions target improvement in last-miles services, a market intelligence platform and application of CRM/MRM for better performance.

In order to provide more customized assistance and capacity building, there is a need to assess current practices at the selected BSOs. This TOR is for the service to depict and analyse existing internal management procedures at 06 BSOs for two sectors of TW and VAT. The results of the assessment will help to boost the application of CRM/MRM in 2019 and 2020.

OBJECTIVES

The following objectives are set for the assignment:

- Reviewing and scanning the current internal resouces and processes of the BSOs
- Revising the existing in-house filing/documentation system
- Studying the customer contact management in preparation for CRM/MRM inputs
- Recommendations for improvement of Customer/Client and Data management system.

SCOPE OF WORK

The service will be conducted for 06 BSOs : (1) Handicraft and Wood Association of Ho Chi Minh City (HAWA);(2) Binh Dương Furniture Association (BIFA); (3) Forestry Product Association of Binh Dinh (FPA); (4) Vietnam Textile Apparel Association – Ho Chi Minh city Branch (VITAS); (5) Ho Chi Minh City Textile and Garment - Embroidery Association (AGTEK) and (6) Vietnam Chamber of Commerce and Industry – Ho Chi Minh City.

DELIVERABLES

- A synthesis report on internal resources of the BSO: website, internal working process, code of conducts, office manual, contact management, office archives...
- An assessment and recommendations for 06 BSO home pages to advance their visibility and external

communications

- Suggestions for improvement on internal process and data management
- Suggestions in forms of standardized key processes with explanation and visualization.
