Independent certification bodies verify compliance with the 4C requirements. 4C was developed in a comprehensive and transparent multi-stakeholder process involving coffee producers, trade and industry as well as various civil society organizations from around the world. The aim of 4C is to move the entire coffee sector towards sustainability. 4C operates in 25 countries and is one of the largest certification systems in the coffee sector.
