# I. BACKGROUN INFORMATION

World Vision is a Christian relief and development organisation working to create lasting change in the lives of children, families and communities living in poverty. World Vision serves all people regardless of religion, race, ethnicity or gender. As a child-focused organization, WV's work focuses on children, ensuring they are protected and their basic needs are met. WVV has a total income of around US\$ 19,000,000 (FY20) with funding from 14 support countries in Europe, Asia, the Americas and Australia. The strategic focuses of WVV include: children protection from all forms of abuse, exploitation, violence and injury; reduction of malnutrition rate of children under 5 through integrated approach; sustainable livelihood for poor households to support sustainable well-being of children.

In 2018 World Vision International in Vietnam commenced the "Tackling Online Child Sexual Exploitation Project" with the financial support from the Fund to End Violence against Children. The project aimed to protect children and adolescents from online sexual abuse and exploitation. As the project closed in October 2021, an external consultant was hired to conduct an evaluation of the project in July-August 2021. The evaluation report, albeit comprehensive, logically structured and coherent, needs to be fully edited in English to enhance the quality for national and international dissemination.
