B. PROJECT BACKGROUND

The USAID Sustainable Forest Management Project (the Project) will work with the Government of Vietnam (GVN) to reduce carbon emissions associated with deforestation, the degradation of natural forests, and poor plantation management. The Project will implement a "Green Prosperity" approach that strengthens local communities ability to protect their natural resource base and reduce emissions while building a strong foundation for sustainable livelihoods and equitable economic growth.

The Project will work in seven provinces (Lao Cai, Son La, Hoa Binh, Thanh Hoa, Nghe An, Quang Tri, Quang Nam) and focus on five objectives:

- 1. Improve and expand community forest management
- 2. Increase conservation-friendly enterprises in forest-dependent communities
- 3. Increase functionality of law enforcement system for forest crimes
- 4. Improve production forest management practices
- 5. Mobilize domestic resources for forest management and protection



The Project will be implemented during the period 2020-2025 by DAI in collaboration with RECOFTC and Preferred by Nature as partners, with the Ministry of Agriculture and Rural Development (MARD) as the counterpart and the Management Board of Forestry Projects (MBFP) as project owner.

C. DESCRIPTION OF CONSULTANCY SERVICE:

I. BACKGROUND OF THE ASSIGNMENT

1.1. Background

Forest rangers are one of the important forces in the fight against Forestry crimes in the forestry sector. Rangers are also assigned some initial investigation activities for a number of Forestry crimes in the forestry sector. However, the majority of forest rangers have extensive forestry expertise, a few managers and legal staff have professional qualifications in law. Very few forest rangers have knowledge and experience in criminal offenses in the forestry sector, and rangers' investigative competence; on detecting, investigating and handling Forestry crimes in the forestry sector.

In addition, the criminal law and criminal procedure in Vietnam are very complicated and change frequently, making it difficult for the police force to fight and prevent Forestry crimes in the forestry sector. forest. Despite great efforts, the forest rangers have only managed to handle a small number of Forestry crimes in their respective fields. Forest rangers urgently need to be equipped with more knowledge and skills on competence, criminal offenses and criminal investigation in the forestry sector.

1.2. Legal basis

Investigative tasks and powers of forest rangers assigned to conduct a number of investigative activities are specified in:

- Law on Organization of Criminal Investigation Agency 2015
- Penal Code 2015, amendments and supplements 2017
- Criminal Procedure Code 2015
- Other legal documents related to criminal and criminal proceedings.

The Project requires two consultants, one with expertise in criminal offenses in the forestry sector and the other one with expertise in investigating criminal offenses in the forestry sector. The two consultants will work together to conduct a training course on Forestry crimes and criminal investigation in the forestry sector for forest rangers.

This SOW is for the Forestry crimes investigation consultant in forestry sector.

2. OBJECTIVES OF THE ASSIGNMENT AND TASKS

2.1. Overall objectives

This training course aims to equip forest rangers involving in investigating and handling forestry crimes (a) basic knowledge about Forestry crimes in the forestry sector, (b) forest rangers' investigative competence, and (c) investigation skills on forestry crimes that contribute to law enforcement strengthening and sustainable forest management.

2.2. Specific tasks

The 3-days training course is to equip students with basic knowledge and skills on:

- 1. Classification of reports of Forestry crimes and grounds for prosecution of criminal cases
- 2. Receiving and handling denunciations and reports of Forestry crimes in the forestry sector
- 3. Taking testimonies from witnesses



- 4. Exploring the scene, collecting and filing evidence
- 5. Request for expertise
- 6. Procedure for Prosecution of cases, prosecute the accused
- 7. Investigation planning
- 8. Take preventive measures to the suspected/accused (arrest, detain, etc.)
- 9. End of investigation
- 10. Transfer the case file to the People's Procuracy/Court/Investigative police agency

3. SCOPE OF WORK

Forestry crimes investigation consultant in the forestry sector will conduct the following tasks:

- I. Coordinating with Forest Rangers, DAI and Consultant of Forestry crimes in the forestry sector in planning to conduct training courses;
- 2. Development of training materials and practical exercises
- 3. Conduct training in the project area according to the assigned program
- 4. Evaluation of training report writing.

4. LOCATIONS

The consultant will carry out the trainings in designated provinces including Son La, Hoa Binh, Thanh Hoa, Nghe An, Quang Tri and Quang Nam.

D. CONSULTATION TIME (LOE) AND DELIVERABLES

The estimated consulting days for each training is 7 days per training per province for Forestry crimes investigation consultant, scheduled from February to August 2023 including field trips in the Project locations. The specific products to be delivered are as follows:

- Having practical experience as prosecutors, investigators, judges is an advantage;
- Have worked in Vietnamese law enforcement agencies;
- Good facilitating, presentation skills;
- Good reporting skills;
- Able to use Microsoft office applications such as word and excel, data analysis tools and software;
- Speaking English is not compulsory, but is an advantage.
