
Duration: Starting ASAP for three years contract

Main responsibilities:

- The provision of technical advisory services to the national counterparts in the Ministry of Finance (MoF) in the area of green finance policy as well as green financial instrument development with a particular focus on gender, including green bonds, green tax incentives, carbon credit exchange development, etc.
- The preparation, coordination and implementation of nationwide project activities, amongst others the organization of technical trainings, workshops, research and analysis, in cooperation with partner and project staff
- The technical support to the formulation of monitoring guidelines for green investment flows, and to the development of incentives mechanisms for public and private finance of green as well as energy projects
- The preparation and establishment of policy cooperation between relevant ministries, e.g. SBV, MPI, MONRE, MoIT, and other key stakeholders, as well as active facilitation and participation in those cooperation formats
- The monitoring, evaluation, documentation and dissemination of the implementation of activities and their impacts
- The support of other project activities when required

- Experience in working with relevant governmental institutions in Viet Nam preferably with the Ministry of Finance and financial regulators. Experience working with international development organizations would be an asset
- Excellent understanding of the technical and organizational framework of Viet Nam's financial and financial regulatory system with a strong focus on green and energy finance especially for women
- Excellent, technical understanding of green bond frameworks, sustainable finance taxonomies and carbon market development
- Excellent cooperation and networking skills across different actors, institutions and personalities
- Excellent leadership, communication, research and presentation skills with a strong interest in international cooperation and development
- Excellent language skills in Vietnamese and English, knowledge of German would be an asset, excellent IT-skills are a must (e.g. Excel and other MS Office programmes)
- Willingness to travel, both within Viet Nam and possibly abroad
