- 5. 02 sample reports: 01 report from the company and 01 report from team leader.
- 6. Evidence of sustainability criteria (if any).

The competitive offer package must be received no later than 24:00 –22<sup>nd</sup> Dec 2024. Failure to meet the closing time may result in the offer being void.

- > Technical proposal and commercial proposal should be submitted in 2 separated emails.

- The subject of the email should be "PR560957-ANCP2-"Go to market Strategy for "Vui đọc cùng em" Reading Application" 'Supplier Name', 'Date', Technical proposal/ Commercial proposal.
- > All attached documents should be clearly labelled so it is clear to understand what each file relates to.
- Emails should not exceed 15mb if the file sizes are large, please split the submission into two emails.
- > Do not copy other SCI email addresses into the email when you submit it as this will invalidate your bid.
