# **Scope of work**

Collaborator for implementing and monitoring project activities in Kon Tum province

Project "Improving the quality of life of persons with disabilities in provinces sprayed with Agent Orange" in Binh Dinh and Kon Tum provinces (Inclusion 2b)

### **BACKGROUND**

Catholic Relief Services (CRS) is an international non-government organization, operating in Vietnam since 1994. In partnership with the government and communities, CRS implements programs in 13 provinces/cities in Vietnam. The Vietnam Program has a diverse funding base in the sectors of Disabilities, Mine Action and Disaster Risk Reduction and Management, and Community-based Climate Change Adaptation.

The Disability Program focuses on supporting integrated inclusion of people with disabilities through establishing model, developing inclusive education for children with disabilities, capacity building for organizations of people with disabilities and parent association of children with disabilities.

With funding from USAID, CRS is implementing the project "Improving the quality of life of persons with disabilities in provinces sprayed with Agent Orange" in Binh Dinh and Kon Tum provinces (Inclusion 2b) in partnership with the HI Foundation. During the implementation of Inclusion 2b project, CRS is implementing activities in Binh Dinh and Kon Tum provinces including home-visit mentoring in home-based care for persons with significant disabilities; mentoring in care for persons with disabilities before discharge; prevent and response for gender-based violence against persons with disabilities; and psychological support for persons with disabilities and their family caregivers (this activity is conducted in Kon Tum).

To enhance the effective implementation of activities and monitoring the quality of the project, CRS is seeking a collaborator (preferably a field-based person in Kon Tum province) to support the project with detail scope of work as follows:

### I. Objectives:

- Support in implementing project activities regarding social support for persons with disabilities in the community in project areas within Kon Tum province, with primary focus on DakHa and DakTo districts.
- Support the monitoring of project quality, including reviewing reports of local trainers and care mentors, analyzing results collected from home-visit mentoring activities and providing recommendations; conducting home-visit monitoring; cooperating with project officers from CRS and technical experts to discuss the lessons learned and suggestions for improvement.
- Support in organizing reflection meetings regarding social support activities in the community.

#### II. Scope of work:

The collaborator will coordinate with the CRS project staff to carry out the following tasks at the local level:

- Participate in team meetings to discuss the implementation plan for project activities.
- Support the organization of quality monitoring home-based care activities such as CRS MEAL monitoring visits, external care expert monitoring visit.
- Review reports of local trainers and care mentors, providing analysis on the effectiveness and consistence with the care plans.
- Conduct home-visits to monitor and assess the effectiveness of project interventions.
- Write monthly reports following monitoring visits (at least one report per month)
- Support in data compilation including case tracking and report entering on the online system.
- Support logistical tasks during the implementation of project activities in project areas.

- Having at least 3 years of working experience in supporting community, development projects of international or local organizations, preferable to working experience with persons with disabilities.
- Having good teamwork and personal communication skills, ability to observe, cover and evaluate project activities in the community.
- Excellent skills in using Microsoft software such as Word, Excel, Powerpoint., Teams and other online communication application
- Having English skills is an advantage.
