ROLE PURPOSE

Plan International is a development and humanitarian organisation that works together with children, young people, supporters and partners to strive for a just world, where we are all equal.

This position is accountable for the management and implementation of the project in Quang Binh province to achieve the project's objectives and targets, contributing to the ambition of Plan International Vietnam so 2 million girls in Vietnam will learn, lead, decide and thrive.

DIMENSIONS OF THE ROLE

The Project Coordinator, under the supervision of the Provincial Partnership Manager, will be responsible to manage and deliver the project's activities in accordance with the approved work plan and donor's compliance in assigned Quang Binh province.

Project management: fully responsible for managing the project planning and implementation, monitoring and evaluation and reporting in the assigned location that meet

project's expected outcomes/outputs in line with approved workplan and donor's compliance as well as assuring quality standards are met, including progress towards predefined results and milestones and results contribute to program and organisation's objectives

Project financial management:

- Develop and implement workplan to ensure activities and budget spending in line with the project progress
- Work closely with project financial staff for the project financial management compliance with donor, PIV and government requirements including spending at partners

Partnership and networking:

- Establish, develop and build relationship with partners, technical networking within the project theme
- Maintain an open and accountability liaison mechanism with partners at different levels to ensure the timely information exchange and solutions for any issue emerged during the project implementation.
- Represent of PIV to participate in meetings, network, workshop which are required/called by the donor, partners, networking
- Work closely with Quang Binh Program Unit team to have team members support for project implementation in their assigned locations.
- Ensure technical supports and work mechanism from PIV Country Office teams are integrated into actions to implement in the project

Monitoring, evaluation and reporting:

- Responsible for preparation and submission of program narrative, financial and M&E reports following donor's and organization's reporting schedule, ensuring the quality of those reports.
- Ensure quality project activity implementation with focus on developing and implementing M&E plan and reporting that meet project's expected outcomes/outputs.
- Responsible for communication and reporting to government authorities during the time of project implementation as required

Donor servicing:

- Work closely with Project Manager (from National Office) to ensure all donor's requirements are updated and communicated in timely manners
- Support and coordinate donor/guest visits.
- Provide translation and interpretation when required.
