Point-of-Care Testing: Lipid Panel POC and Lipid Panel Plus Glucose Testing PATH office in Viet Nam March 6, 2025

1. RFI Overview

This RFI is issued to gather information on the availability of Point-of-Care (POC) testing for lipid panel POC as well as lipid panel plus glucose testing, which can be used with the same analyzer. Additionally, we seek details on related commodities such as test strips (Cholesterol Test Strips, HDL-C Test Strips, Triglyceride Test Strips) and blood sampling lancets for this Point-of-Care (POC) testing.
