

## **Terms of Reference**

### **Recruitment of the Technical Experts for the European Union – Vietnam Cooperation Facility (EUVCF)**

#### **General Summary/Background:**

The European Union - Vietnam Cooperation Facility (EUVCF) is a project funded by the European Union Delegation (EUD) to Vietnam and implemented by DT Global, an international development company, during 2024 - 2027 period. One of the activities of this Project is to provide the EU with robust, high-quality consulting services in three main priorities: i) Green and digital economy, ii) Decent and inclusive jobs, iii) Good governance and rule of law, as well as in further cooperation actions to reinforce the successful implementation of ongoing and future EU-Vietnam cooperation activities. - Previous experience working and/or coordinating with different stakeholders (ministries and agencies of the Vietnamese government, international organisations, Team Europe, EU Member State embassies and consulates-general, etc.).
- Previous experience working on EUD-funded projects is preferred.
- Capacity to work in a team in a multi-cultural environment.
- Excellent interpersonal communication and reporting skills.
- Very good English and Vietnamese expression both orally and in writing.
